The Authorised Fund Manager of the Fund is Evelyn Partners Fund Solutions Limited, trading as St Vincent St Fund Administration, part of the Evelyn Partners group.

### Objectives and investment policy

The Fund aims to achieve long-term capital growth over a period of at least 7 years.

The Fund will invest at least 70% in shares of UK companies (those domiciled or incorporated or that have a significant business in the UK). The Fund may also invest in companies listed on recognised UK stock exchanges but which may be domiciled, incorporated or have significant business elsewhere, which, in the Investment Manager's opinion, have good prospects for growth that exceeds that of the wider UK equity market. The focus of the Fund is new economy companies, which the Investment Manager defines as those that utilise new technologies, benefit from innovation, have a sustainability awareness or offer services and products that meet the demands of an evolving global economy.

The Investment Manager also has the flexibility to invest in new issues meaning, typically, Initial Public Offerings (or IPOs), which generally mark the first sale of shares by a privately-owned company in order to gain a stock market listing. However, it may also include "share offers" (meaning sales of stock by companies that are already listed on one of the Fund's eligible markets), which will necessarily have a higher risk than investments in established companies.

The Fund may also invest in:

- shares outside the UK
- other transferable securities
- other investment funds
- cash, deposits and money market instruments
- warrants.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

Any income the Fund generates will be paid out to you.

You can buy and sell units on any working day in London.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.

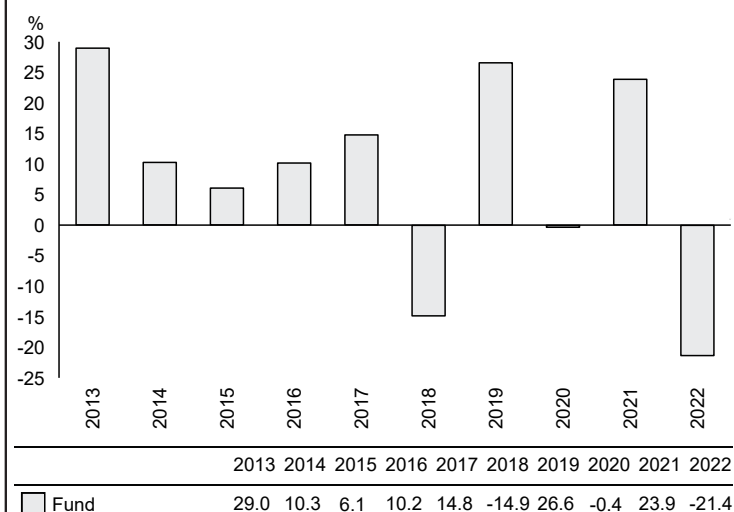

- A dilution levy may be charged on a purchase or sale of units in the Fund in some cases. It may be necessary to reduce the difference between the cost of buying or selling the Fund's investments and the Fund's mid-market unit price. Any dilution levy charged will be paid into the Fund.
