Client cash remains instantly available should you require the cash to either invest into the market or alternatively return to your own Bank Account.

The below rates apply to Sterling Deposits only and are tiered rates:

The below rates apply to US Dollar Deposits only and are tiered rates:

\$0 to \$25,000	0%
\$25,001 to \$250,000	1.25%
\$250,001 to \$1,000,000	1.5%
\$1,000,001 and above	1.75%
